NEW BUSINESS

1. Request by Probation Department, new contract between County of Elk, BTM Software Solutions, LLC, and Corrections Development, Inc. for new case management software "AP Probation". The contract will begin upon its execution in 2025 and continue to 12/31/25. It will renew for successive 1- year periods beginning 1/1/26. The amount due will be \$10,000 in 2025, which includes data conversion and training. First year software licensing fee of \$6,360 is waived. The amount due in 2026 will be \$11,360 which represents the annual cost of software licensing \$6,360 and \$5,000 for web hosting. The County shall have the right to terminate

contract upon thirty (30) days written notice to the provider. The cost of this monitoring program is funded by Court Supervision Fees collected from Probation clients. **Motion by Gregory J. Gebauer, second by Matthew G. Quesenberry and carried unanimously.**

- 2. Request by IT Department, renewal contract between County of Elk and Appalachia Technologies, LLC for maintenance from January 16, 2025 through January 15, 2026 at a rate of \$195.00/hour on an as needed basis. This contract will renew automatically each year with a 5% renewal increase. Motion by Gregory J. Gebauer, second by Matthew G. Quesenberry and carried unanimously.
- 3. Request by Assessment, new contract with Vision Government Solutions, Inc. for Assessment software subscription for one year starting after implementation at a rate of \$39,750.00 per year.
- 4. Request by Assessment, new contract with Vision Government Solutions, Inc. for implementation of CAMA software for a one-time fee of \$188,000.00.

*New Business 3 and 4 were voted on together. Matthew G. Quesenberry stated they were researching this software, but currently do not have enough information to proceed. Matthew G. Quesenberry made a motion to table both items. Gregory J. Gebauer seconded the motion. Patrick Straub gave a brief description of the software and its capabilities. The motion to table passed unanimously.

- 5. Request by CYS, Child Accounting and Profile System Application Service Provider from July 1, 2025 through June 30, 2026 with an increase of \$758.69.

- 6. Lawn Use Request by CYS, banner on the Courthouse lawn from April 4, 2025 through April 30, 2025 promoting National Child Abuse Awareness Month. Motion by Gregory J. Gebauer, second by Matthew G. Quesenberry and carried unanimously.
- 7. Request from Veteran Affairs, approval of benefits for 6 veteran burials, 1 spouse burial, and 4 veteran headstones. Motion by Matthew G. Quesenberry, second by Gregory J. Gebauer and carried unanimously.
